## Message from our President

By the time you receive this *VOTER* the election will be over or almost over. Our League can be proud of a job well done these past few months, registering voters, informing citizens and advocating on the two County ballot measures, and eleven of the California ballot measures..



Now that the election season is behind us, we can look ahead. On January 21, 2017, LWVPA members will have a chance to be involved in **planning our League’s program for 2017-18**. This is a great opportunity for you to participate in the grassroots work of the League. Please put this on your calendar now. See the info on page 3.

We do not need to wait for Program Planning to continue our **advocacy work locally**. Affordable housing promises to be an important issue for our City Council and we will be watching that closely. Equally important is ensuring that our City is well served with adequate transit options for all. LWVPA will be monitoring proposed changes in service by the VTA and, if cuts are made to bus routes, we may urge the City to step up to fill these gaps.

Our active communications team is busy exploring ways to effectively use **social media** to keep the public informed. For the first time, LWVPA ran an ad on Facebook with information about our voter services activities. This ad reached over 8,000 people, most of whom viewed it on their smart phone. **Facebook is a tool that can benefit all of us, if used wisely and within League guidelines**. Try Facebook, if you have not already done so. Once you are on Facebook, you can find our LWVPA page by searching for League of Women Voters of Palo Alto. If you have a Facebook account, you can “like” our page and see our updates whenever you’re on Facebook.

## Advocacy Report by Lisa Ratner

### LWV Palo Alto

#### Getting the Word Out: League Positions on CA Ballot Initiatives

LWVPA has publicized the LWVCA positions on eleven of seventeen California Ballot Initiatives in the Palo Alto Weekly, and in a Facebook ad. We also posted LWVCA positions on our Facebook page, in the *VOTER*, and on our website.

#### VTA Cut-backs.



Our Housing and Transportation Committee is continuing to monitor **VTA plans to cut its VTA bus service to Palo Alto** which would mean loss of

service to middle school and high school students, and to the elderly and disabled who depend on paratransit service, which is linked to dedicated public transit routes. Limited funds force a tradeoff between frequency of public transit and coverage. We will be drafting a letter to the VTA in consultation with LWV Santa Clara County Council, as this is both a local and county issue. Goals will be to adopt a VTA plan 1) which decreases traffic congestion (attracts riders who would otherwise use a car with reliable, frequent services) and 2) in which vulnerable populations will not be abandoned, whichever entity (city, county, public/private shuttles/buses) ultimately provides services.

#### Affordable Housing.

Members of the HTC observed a study session of the Palo Alto City Council on October 24 in which Palo Alto Housing (local nonprofit affordable housing developer) detailed its history of building affordable units in Palo Alto since the mid-1970's. Because of the political climate in Palo Alto after the defeat of PAH's Maybell affordable senior housing project, PAH began to pursue affordable housing projects in

Mountain View and Redwood City, where greater density for affordable housing is allowed. At the end of the study session, Palo Alto City Council directed its planning staff to research whether the PC zone (whose use had been suspended after the defeat of the affordable senior project) or some variant could be redrafted to allow affordable housing projects in Palo Alto. The Mayor suggested that perhaps the LWVPA could convene a community dialogue on affordable housing in Palo Alto.

#### Update of LWVPA Climate Change and Natural Resources positions/goals.

Phyllis Cassel continues to chair an LWVPA study group which will meet on November 18, 1:30-3:30 pm to review these topics. New members are welcome. Email [lwvpaoffice@gmail.com](mailto:lwvpaoffice@gmail.com) if you are interested in joining this discussion.

#### Responsible Gun Ownership Committee.

### LWV Bay Area and LWV California

#### Public Financing of Elections

LWVCA President Helen Hutchison recommends that local Leagues consider whether to help local jurisdictions adopt local public financing of election laws because SB 1107 eliminated the ban on public financing for general law cities, counties, and districts.

#### Bay Area League Day

LWVBA reports that affordable housing will be the topic at the 2017 Bay Area League Day. LWVBA also reports that the Bay Area Quality Management District has adopted a new civic engagement tool, the Open Air Forum, which provides for citizen feedback on specific issues of air quality. ## Outstanding Election Season Work from our Voter Services

Voter Services work at the League involves two kinds of activity: helping citizens to be ready to cast their vote and providing opportunities to inform the public about candidates and propositions, both state and local. Helping citizens to vote involves sessions to register citizens to vote for the first time. We also answer individual questions about changes of address, or name, how to vote by mail, how to get a second ballot when the first had to be scrapped, and what to do about students who are away at college in a different state. The Registrar of Voters of Santa Clara County staff are always very helpful.

Informing the public about options on the ballot involves two types of activity: forums for candidates for public office, and events about the pros and cons of propositions on the ballot.

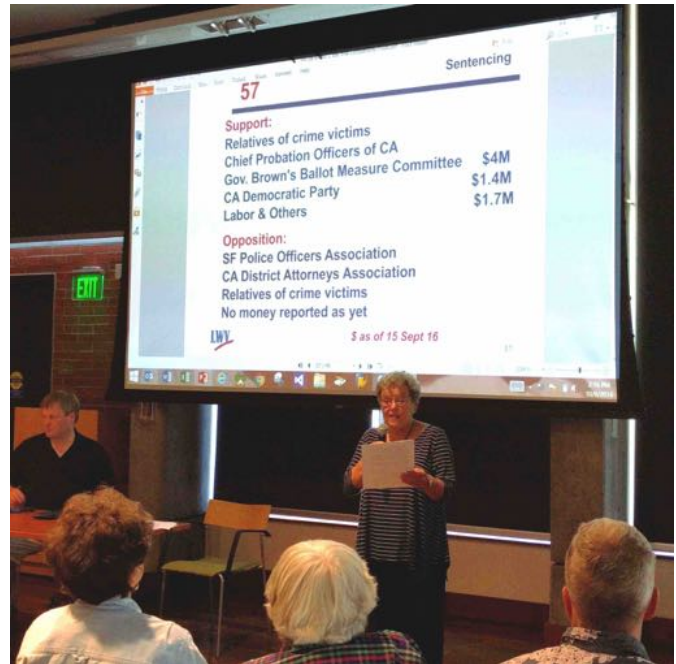
### Candidates Forums

Following the Candidates for Palo Alto School Board Forum in September, we held a very successful Candidates for Palo Alto City Council Forum on October 5th for ten candidates. There were good questions from the estimated 150 people in the audience. Midpen Media Center posted the videos of our two Forums on the web on Youtube.

### Pros and Cons Events about the State Propositions and Local Measures

We put on twenty-one Pros and Cons events this fall, six of which were open to the public. The 17 state propositions were simply too many to discuss in one setting, so at each event we discussed the 12 that were the most complex, plus the two county measures. We always took questions from the audience at the end. An estimated 880 people attended our Pros and Cons events.

A common question both at those events and on our office phone concerns the League recommendations.

We do not answer that question at Pros and Cons events but we published our recommendations in our newsletter, in an ad in the local paper and on Facebook. In addition, our website is a fount of information.

### Discussions at Stanford about specific Propositions

One of our members organized two very successful events at Stanford. In September, we held a discussion at the Law School about the death penalty propositions, and in October we held a discussion about the proposition to legalize marijuana.

### New Members

Even though the election is over, we will continue to do Voter Services work. I will be reaching out to new members who are interested in this aspect of our LWV work to join me for coffee and conversation and to get to know one another.

## New Voices (NV4Y) Update



This summer, Erendira Parra, a New Voices alum from Menlo-Atherton high school (M-A), led New Voices summer programs at Siena Youth Center in Redwood City and at Puente, a community program for youth in Pescadero. Erendira writes, “At the beginning of the class I showed documentaries dealing with social justice issues along with showing short documentaries so they could get the basic idea of the story structure. After showing them profile pieces done by other students at NV4Y, I asked them to each come up with five different topics relevant to them that touch on social justice in their community. Then I grouped them based on what most interested them in their community and from there they decided as a group what they wanted their film to be about. Overall students at Siena and at Puente were both eager to get their hands on a video camera and just shoot, along with greatly anticipating showing their final projects to their peers.”
