Advocacy Report by Lisa Ratner

California

LWV California has issued a call to action on the California Values Act, SB 54, which has passed the state senate. LWV urges citizens to contact their assembly members to vote for SB 54. According to the LWVC, the California Values Act will:

- Prevent state and local law enforcement from acting as federal immigration and customs enforcement agents to detain and deport immigrants
- Ensure state and local governments do not send data to the federal government for immigration enforcement purposes
- Make certain our schools, hospitals and courthouses remain safe and accessible to all Californians.



The author of the bill, Speaker Kevin de León, commented in the bill analysis that the purpose of the bill is to protect the safety and well-being of Californians by ensuring that state and local resources are not used to fuel mass deportations, separate families, and ultimately hurt California's economy.

Speaker de León went on to comment: "The President has stated that he will order the increased deportation of a broad category of immigrants" (not just those who have committed serious felonies). "Any expansion of deportation efforts will have a significant effect on California's economy and society."

"A relationship of trust between California's immigrant residents and our state and local agencies, including police, schools, and hospitals, is essential to carrying out basic state and local functions. That trust is threatened when state and local agencies are involved in immigration enforcement."

De León further commented: "Immigrants often fear approaching police officers when they are victims of and witnesses to crimes and when local police are entangled with federal immigration enforcement." President Obama's Task Force on 21st Century Policy took the view that whenever possible, state and local law enforcement should not be involved in immigration enforcement.

"California is familiar with the harmful effects of entangling local law enforcement agencies with immigration enforcement. The Secure Communities Program (S-Comm) operated in California as an indiscriminate mass deportation program at great cost to California. It has been estimated that when the Secure Communities Program was still active, California taxpayers spent an estimated \$65 million to detain people for ICE," including the cost of foster care for children separated from their parents.

Local

LWV Palo Alto's Housing and Transportation Committee commented on the proposed EIR for the Comprehensive Plan, urging the city council to adopt the scenario for the highest number of housing units planned for the city. The Council adopted a scenario which planned for a mid-range number of housing units, 4-6,000.

LWVPA also commented on the proposed changes to the city's below-market-rate (BMR) housing inclusionary and impact fee ordinances. The City Council ultimately adopted fees that will be lower than those which were originally proposed and added language to make it easier for developers to pay in-lieu fees when providing BMR units is impractical.

Proposed modification to the LWVPA bylaws:

ARTICLE VIII Financial Administration: **Section 2** Dues :

Annual dues shall be determined by a majority vote of the local League members present at the annual meeting and shall be payable by each member on July 1 of each year. Upon joining, each member will pay the full annual dues. In the first anniversary month of joining, dues will be charged prorated to the following July 1. There shall be a dues reduction of *to no more than* one-half for each additional member of the same household residing at the same address. Any member who fails to pay dues within sixty (60) days after they become payable shall no longer be a member of the LWVPA.

ARTICLE III Membership, **Section 2A** Types of Membership/Voting Members:

A. Voting Members. Persons at least 16 years of age who join the League shall be voting members of LWVPA, LWVC, and of the LWVUS; (1) those who live within an area of LWVPA may join LWVPA or any other local League; (2) those who reside outside the area of LWVPA may join LWVPA or shall be state members-at-large; (3) those who have been members of the League for 50 years or more shall be life members excused from the payment of dues.

Budget Notes

The budget was developed by our budget committee and approved at the Board meeting of March 28, 2017 for recommendation at the annual meeting.

The largest change is the proposal to raise the yearly membership dues from \$70 to \$85 per individual member, and from \$35 to \$40 for each additional household member and for student members.

The proposed change is based on three findings: 1) our local League keeps only \$8-9 of the \$70 membership dues as we send the rest to support vital state and national League efforts; 2) our costs go up each year; and 3) we have not raised the dues since 2010.

The budget adds money for new communication outreach and for meeting expenses that we do not recover in fees.

The largest discretionary item in the 2017-18 budget is the expense item to help delegates attend the national convention in Chicago in June 2018.

Most other budget items follow recent trends or were determined by the budget committee.

Local Position Updates

Proposed updates to the LWVPA positions on Natural Resources, the Housing position under Social Policy and the City Finance position under City Government have been reviewed by the Board and will be voted on by membership at this Annual Meeting. In addition, a resolution on the urgent need to act on issues related to community sustainability and climate change is proposed. The recommended updates are available in entirety for review on our website at <http://www.lwvpaloalto.org>.

Printed below is the cover paragraph to the policy changes and the proposed resolution.

LWVPA positions on Natural Resources and the Housing position under Social Policy were reviewed in 2017 in light of current concerns about sustainability and climate change. Some modifications to our positions were made, primarily to make specific reference to climate change, to adopt current terminology, and to remove portions that have become outdated. This also resulted in moving one objective to the City Finance position under City Government. A resolution on the urgent need to act on issues related to community sustainability and climate change is proposed.

Resolution by the League of Women Voters of Palo Alto on Sustainable Communities and the Impact of Climate Change. For approval on May 13, 2017

Whereas the League of Women Voters of Palo Alto recognizes the urgent need to act on issues related to Sustainable Communities and Climate Change, and

Whereas the LWV of California states in its Sustainable Communities position that the concept of sustainability is implicit in the Principles of the League of Women Voters of the United States and that League positions are in compliance with the fundamental principle of sustainability, recognizing the interdependency among issues of public policy and the impact of current decisions on the global welfare of future generations, and

Whereas the LWVC defines sustainable communities as those that recognize their interdependence with the global community and seek to meet current economic, environmental, and social demands through equitable and democratic means without compromising the ability of future generations to meet their own needs, and

Whereas LWVUS, LWVC, LWVBA, and the Leagues of Santa Clara County have multiple positions that address these issues and that can be used by the LWVPA to take action both at the local League level and at other League levels, and

Whereas these positions were developed after member study and a consensus process and ultimately were adopted by the members and are reviewed at annual meetings and conventions, sometimes with a major review and update to keep them current, and

Whereas the Natural Resources positions include environmental protection and pollution control, air quality, energy, hazardous materials, land use, solid waste, transportation, water resources, nuclear waste, flood control management and agriculture policies, and

Whereas these policies are interactive and part of an interdependent web which includes other positions such as housing, “good government,” and financing policies, and

Whereas other League levels have been active to effect the sustainability goals over many years through support of legislation, education, and on occasion litigation, and

Whereas the LWVPA has been active in promoting sustainable communities through educational meetings on topics such as rising sea level; in promoting updates to the water quality control plant; in encouraging denser housing located at the core of the city and not in the Baylands or Foothills; and in encouraging better mass transit, and

Whereas the LWV recognizes that the interdependent web of issues of sustainability reaches across municipal, regional and state boundaries,

Therefore be it resolved that the League of Women Voters of Palo Alto will work to reduce the impacts of climate change and to encourage sustainability in Palo Alto and its neighboring communities.

Why Your Board Recommends a Dues Increase

At the Annual Meeting on May 13, members will be asked to approve an increase in dues from \$70 to \$85 per individual member and from \$35 to \$40 for each additional household member and for student members. It is the first increase in seven years and important to continue our League's excellence moving forward.

What do your membership dues support? League work at all levels!

For each \$70 membership dues:

\$32 goes to support the work of the League of Women Voters of the United States to address critically important issues such as voter suppression and voting rights

\$28 goes to support the work of the League of Women Voters of California to address issues such as money in politics, climate change, housing and education

\$1 goes to support the work of the League of Women Voters of the Bay Area to address regional environmental, transportation and housing issues

About 30 cents goes to the League of Women Voters of Santa Clara County to work on county-wide issues

Our local League uses the remaining \$8.70 from your dues to support our local work.

The last increase in membership dues was approved at the 2010 Annual Meeting: from \$68 to \$70 per individual member, and \$35 for each additional household member or student. During the last seven years our costs have continued to rise.

Therefore, your Board of Directors voted to recommend to the membership at this year's Annual Meeting the dues increase described above. With the proposed increase, LWVPA would have \$15 more per individual member. This increase is reflected in our Proposed Budget for 2017-18.

These additional funds, along with our strong fundraising program, will help us pursue our efforts to continue and expand our outstanding programs to educate, inform, advocate and communicate in the years ahead.

Thank you for being a League member and for supporting our activities to strengthen democracy and civic life. From the local level up—throughout the country—your membership is making a difference!
